

રફેલને કફલામાં સામેલ કરવા ભવ્ય સમારંભ યોજાશે: મોદી, ફાંસના સંરક્ષણ મંત્રી હજાર રહેશે

નવી દિલ્હી તા.૨૧ અંબાલા હવાઈ મથકે રાખવામાં આવેલા રાફેલ વિમાનોને વાયુદળમાં ઔપચારિક રીતે સામેલ કરવા ટુંક સમયમાં ભવ્ય સમારંભ યોજાવાનો છે. એમાં વડાપ્રધાન મોદી અને ફાંસના સંરક્ષણ પ્રધાન ક્વેરેનસ પાર્લી હજાર રહે તેવી શક્યતા છે.



સૂત્રોના જણાવ્યા મુજબ આગામી સપ્તાહમાં આવો સમારંભ યોજાવાનો છે, પણ તારીખ હજુ નક્કી કરાઈ નથી. આમ છતાં, વાયુદળ દ્વારા પુરસ્કૃતમાં તૈયારીઓ ચાલુ છે.

પાંચ રાફેલ જેટને વાયુદળની કાર્યપદ્ધતિ સાથે સંકેતિત કરાઈ રહ્યો છે, અને તે આવ્યા પછી ટેસ્ટરેન્જમાં તેમણે સફળતાપૂર્વક શસ્ત્રો છોડી તેની ઓળખને સાર્થક કરાવી છે.

ચીન સાથે સરહદી તંગટીલી ફાંસ રાફેલ કાઉન્ટર જેટના મોટા

જાહેરાત કરી દ્વિપક્ષી મુલાકાત માટે વિનંતી કરી હતી. અંબાલા ખાતેનો સમારંભ સ્થિત મુલાકાતનો ભાગ બનશે.

રાફેલની પ્રથમ ટુકડી ૨૯ જુલાઈએ અંબાલા આવી પહોંચી હતી. એ વખતે વાયુદળે જાણાવ્યું હતું કે ઔપચારિકપણે વાયુદળના બેડામાં તેમને સામેલ કરવાનો સમારંભ ઓગષ્ટના બીજા ભાગમાં યોજાશે.
